3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
4. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

6. It will continue to pay an Annual Fee of Rs. 3000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of **Secretary, CBSE, payable at Delhi**. This may be complied in future.
7. **Annual fee has been received upto 31/03/2018.**
